Billing Information: Fees are at the rate of \$100 per hour for Energy Healing Therapy Sessions, \$60 for a half hour Vibrational Sound Healing session. Intuitive readings are available at the following rates; \$40 for a thirty minute reading, \$55 for a forty five minute reading, \$70 for a sixty minute reading. Prepayment is required for all sessions and can be made with cash, check, credit card, or Paypal (sopriceles@gmail.com). All other financial arrangements must be agreed upon prior to appointment. Also available are discounted prepaid packages; Three sixty minute Energy Healing Therapy sessions for \$250. Two Vibrational Sound Therapy sessions for \$100. Three Vibrational Sound Therapy sessions for \$120.

Billing begins at the time of the appointment regardless of tardiness of the client. Missed appointments will be billed as a one-hour appointment, unless a minimum of 24 hours notification has been given.

Confidentiality: Hypnotherapists practicing for a fee in Washington must be registered or certified with the Department of Health for the protection of the public health and safety. Registration of an individual with the department does not include recognition of any practice

standards, nor necessarily imply the effectiveness of any treatment. Please be advised that your hypnotherapist cannot disclose any information you have told them during a private session except as authorized by RCW 18.19.180: which provides for disclosure, with the written consent of that person, or in the case of death or disability, by the person’s personal representative; a communication that reveals the contemplation or commission of a crime or harmful act; if the person is a minor, and information indicates said minor was the victim of a crime; if the person waives the privilege by bringing charges against the therapist; in response to a subpoena from a court of law; or as required under chapter 26.44 RCW.
